

No. 20.] *Village of Dennery Loan (Water Works) Ordinance, 1911, Amendment Ordinance, 1915.* [1915.]

The Ordinance may be cited as the Village of Dennery Loan (Water Works) Ordinance, 1915 Amendment Ordinance, 1915, and shall be read and construed as one with the Village of Dennery Loan (Water Works) Ordinance, 1911, hereinafter called the principal Ordinance.

In section three of the principal Ordinance is hereby repealed and the following section substituted in lieu thereof:—

(1) The Council shall be empowered to grant and to issue right of way and to grant and to issue licences for the use of any part of the Village of Dennery Loan for the purpose of carrying out the provisions of this Ordinance, and to make any bye-laws and to alter any bye-law from time to time for the purpose of giving effect to the provisions of this Ordinance.

(2) On each of the dates aforesaid the Treasurer shall transfer the said sum of fifty-one pounds from the revenue of the Village of Dennery Loan in his hand to the credit of the public funds of the Colony.

Provided that in addition to the payments herebefore mentioned the sum of £500 being the sum of five hundred pounds shall be paid out of the said loan of the said Government to the Treasurer of the said Village of Dennery Loan for the purpose of enabling him to carry out the provisions of this Ordinance.

AN ORDINANCE to amend the Village of Dennery Loan (Water Works) Ordinance, 1911.

[ 9th December, 1915. ]

**BE** it enacted by the Governor, with the advice and consent of the Legislative Council of Saint Lucia, as follows:—

Short title.

1. This Ordinance may be cited as the Village of Dennery Loan (Water Works) Ordinance, 1911, Amendment Ordinance, 1915, and shall be read and construed as one with the Village of Dennery Loan (Water Works) Ordinance, 1911, hereinafter called the principal Ordinance.

Repeal of section 3 of Ordinance No. 9 of 1911 and substitution of new section.

Repayment of loan by annual instalments of £51.

2. Section three of the principal Ordinance is hereby repealed and the following section substituted in lieu thereof:—

“ 3. (1) The said sum of eight hundred pounds with interest thereon at the rate of Four pounds per centum per annum shall be repayable out of the revenues of the Village of Dennery by twenty-five equal yearly payments of Fifty-one pounds each on the first day of October in every year, the first of such payments to be made on the first day of October, 1916.

(2) On each of the dates aforesaid the Treasurer shall transfer the said sum of Fifty-one pounds from the revenues of the Village of Dennery in his hand to the credit of the public funds of the Colony.

Provided that in addition to the payments hereinbefore mentioned the sum of Twenty-four pounds, being the interest which will accrue and become due for the nine months ending 30th September, 1915, on the said loan of eight hundred pounds shall be payable out of the revenues of the Village of Dennery, and the Treasurer shall on the first day of October, 1916, transfer the said sum of Twenty-four pounds from the revenues of the Village of Dennery in his hands to the credit of the public funds of the Colony.”

Repeal of Ordinance No. 14 of 1911.

3. The Village of Dennery Loan (Water Works) Ordinance, 1911, Amendment Ordinance, 1911, is hereby repealed.
